Ring at Atlantic City to Be Ready for First Workout at 3 This Afternoon.

ATLANTIC CITY, N. J., Aug. 24.— Jack Dempsey will begin training here tomorrow for the defense of his title against Gene Tunney on Sept. 23 in Philadelphia. The champion is ready for a resumption of the prepara-tory grind which was interrupted by the transfer of the title match to Philadelphia.

After a good night's rest, Dempsey After a good night's rest, Dempsey arose early this morning. He took a brisk walk on the Boardwalk and appeared in better trim than upon his arrival on Monday afternoon. The traces of weariness which plainly bespoke the strain of the trip from Saratoga to New York and from New York to Philadelphia and a day of fêting were gone. In spirit, too, Dempsey was changed. He laughed and joked with the boxing writers and with many visitors who crowded the suite Dempsey occupies with Mrs. Estelle Taylor Dempsey at the Ambassador. Moves to Bungalow Today.

The champion completed negotiations today through Gene Normile, his business representative, for a room and bungalow at 205 Florence Avenue, West Atlantic City, and will establish living quarters there tomorrow night.

With Mrs. Dempsey, the titleholder started on what was planned as a shopping tour, walking along the Boardwalk, but the pair had progressed only about a quarter of a mile when some youngster identified the champion. In the wink of an eye a throng had collected, in which youngsters predominated, the majority of them in bathing suits. Traffic was soon blocked in both directions. Dempsey put Mrs. Dempsey into a wheelchair, and, jumping in himself, gave orders to proceed speedily to the Ambassador.

Progress, however, was slow, for youngsters seemed to grow up out of the ground to swell the initial throng. the ground to swell the initial throng. The construction work on the ring and the gymnasium platform which adjoins it at the dog race course had not been completed this afternoon, but assurances have been received that the work would be finished tomorrow morning at 10 o'clock.
