

## COMPLAIN OF BUS 'PEEPERS'

Washington Women Say Upper-Deck Passengers Watch Windows.

WASHINGTON, March 12 (AP).—Residents of this city who generally occupy the position of sideline spectators as national issues come and go, or linger forever, in Congress, now have an issue of their own that threatens to divide them into two factions—those who ride the upper deck of passenger busses and those whose second floor bedrooms may be viewed by the former.

The controversy is one-sided thus far, with two complainants criticizing the "double-deck peepers" and no spokesman appearing for the bus riders. The District of Columbia Public Utilities Commission, which has the position of referee, however, hesitates to believe that all upper-deck passengers are peeping Toms and has reached no conclusions on that score.

One complaint is Mrs. John B. Henderson, widow of Senator Henderson of Missouri, whose Henderson Castle, on Sixteenth Street, offers a target, she says, for inquiring eyes atop the buses. The peepers, she contends, have taken away "all privacy from second stories."

Mrs. J. G. Willis, another whose residence is on a bus street, had told the Commission that she and her neighbors must keep the upstairs shades drawn to foil inquisitive bus passengers. They felt she said, just "like animals in the zoo."

The two women advocated discontinuance of the bus lines, or re-routing them along other streets.

Meanwhile, the Commission will hear other testimony before attempting a decision.

## FIVE MEN SEIZED IN RAID.

One Wanted in Shooting Found in Post Road Restaurant.

Five men, one of whom was wanted in connection with the shooting last July in Jamaica, Queens, of Henry Salle, a negro, were arrested yesterday morning in a raid by the police on "Jack's Spaghetti House," at 3,525 Boston Post Road, the Bronx. The man charged with the shooting is Philip Dalcastio, 31 years old, of East Main Street, Bridgeport. He is alleged to have shot Salle in an argument over some gin. He was held without bail by Magistrate August Glatzmeyer for examination Monday.

Gindo All, 24, of 749 Main Street, New Rochelle, said to be proprietor of the restaurant, was held in \$500 bail for examination Monday on the charge of maintaining a disorderly house. Giuseppe Tigano, 39, of 41 Putnam Street, Mount Vernon, was held in \$2,000 bail on a charge of attempted felonious assault. The police say he tried to draw a pistol but was disarmed. Tigano produced a pistol permit, signed, it was said, by County Judge William F. Bleakely of Westchester County, dated March 31, 1922, and marked "good until revoked."

Giuseppe Fiencia, a cook, was discharged. Joseph Stosato, 23, of 34 North Fifth Avenue, Mount Vernon, was taken to the Federal Building, and held in \$500 for examination March 30, charged with violating the Volstead act.
