Rickard Locates Headquarters at Congress Hotel and Then Starts for New York.

DEMPSEY REQUESTS PRIVACY

Advises Tex of Desire to Work Only Before Correspondents--Plans Made for Bad Weather.

CHICAGO, Aug. 8.—Applications for seats for the Tunney-Dempsey 8.—Applications fight at Soldier Field on Sept. 22 were opened today at headquarters in the Congress Hotel and the amount of money involved ran into

amount of money involved ran into hundreds of thousands of dollars. Engineers have not yet completed the plan of the seats in the big arena. Tex Rickard said he had ordered 150,000 of the tickets and was ready to begin printing them with a plate especially designed to prevent counterfeiting. The tickets will show likenesses of the two fighters. He said that the scale definitely had been set for \$40, \$30, \$25, \$20, \$15, \$10 and \$5.

Checks should be made out to Tex Rickard or George Getz, the promoters, and sent to the headquarters, congress Hotel, Chicago. The applications and checks will be turned over to a committee of three, possibly five, Chicagoans, who will allot the tickets. These Chicagoans have agreed to serve on this committee provided their names are not made public. The committee has not yet been appointed. provided their public. The cobeen appointed.

Rickard arrived from New York yesterday and returned today for the Delaney-Paulino fight. He will be back in Chicago on Saturday and will remain here until after the fight. back in on will remain

Rickard brought here a part of his office force, chief of staff being a 21-year-old girl, Miss Naoma Lowensohn, his private secretary. Miss Lowensohn will remain here to handle the situation. Rickard is at work on the card of preliminaries which will be part of the program. There will be five or six preliminary bouts, all between heavyweights, of four to six rounds. In case of stormy weather the fight will be postponed a day. "If the weather is threatening," said Rickard," "I will move the main bout forward so it will be held before the preliminaries, or as early as 9 P. M."

Rickard stated that both fighters will box on a percentage basis and if the gate draws \$2,000.000 net Tunney will receive about \$750.000 and Dempsey approximately \$350.000. The formalities of signing new contracts has been set for not later than Aug. 16. Tex said he is expecting both fighters to be in training here on that date.

It was decided today that the ring will be pitched in the centre of the football field.
