Chief Magistrate McAdoo Fixes Rules to Govern Enforcement of Law Now in

## BOON TO AUTO OWNERS

Police Commissioner to Issue "Identification" Cards to Chauffeurs Good Character.

William McAdoo, the new Chief lagistrate of the Boroughs of M Police Magistrate Manhatthe series of the Boroughs of Mannat-tan and the Bronx, announced yesterday the series of reforms in police court pro-cedure by which he hopes to put the Inferior Courts law into effect. Here are the important changes:

Inferior Courts law into effect. Here are the important changes:

Night and Day Courts for Women at Jefferson Market, Sixth Avenue and Tenth Street.

Night Court for men and the Domestic Relations Court at Yorkville Court, Fitty-seventh Street and Third Avenue.

Complaints to be drawn in rooms separate from the courtroom, looking to privacy and order.

The wider use of the summons instead of warrants. Police will be provided with blank books of summonses eigned by the Chief Magistrate.

The Police Commissioner may issue identification cards to persons of known good character to offset arrest, except where absolutely necessary.

Where complaint clerks refuse to take complaints the Magistrate must give audience and pass on the application.

In the Night Court for Women a room is to be set aside for the medical examination and the taking of finger prints.

Bridges in police courts to be removed and witness chairs substituted.

Magistrate McAdoo will open an office at 300 Mulberry Street next week, from which he will direct the work of bringing about the changes in court methods. In discussing his new plans he said:

"Finger prints of women will be taken in only a few cases after conviction. To get the courtrooms readjusted for the use of witness chairs has been very difficult owing to the unwise and improper way in which many of the courtrooms were planned. The most radical change perhaps is that allowing the liberal use of summonses instead of warrants. Under the plan an automobile driver of known good character may get an identification card entitling him to a summons instead of arrest in case of a charge. I think the plan will work when it is once understood."

## LEW FIELDS DENIES RUMORS.
